U.S. TRAFFIC DEATHS JUMP TO **13.5 PERCENT IN 2012** ACCORDING TO THE NATIONAL HIGHWAY TRAFFIC SAFETY **ADMINISTRATION**

According to The National Highway Traffic Safety Administration (NHTSA) traffic deaths in the first three months of 2012 jumped 13.5 % which is the highest number since 2008. The NHTSA estimates 7,630 people died in vehicle crashes in the first three months, a dramatic increase from 2011. This increase ended the steady decline in U.S. road deaths over the last seven years. While the NHTSA continues to record potential causes pertaining to the crashes, texting and other forms of distracted driving are likely causes.

WE GO PINK FOR **OCTOBER BREAST** CANCER AWARENESS

On October 16 we hosted a firm-wide "Go Pink" dress down day to raise funds for the organization Breast Cancer Options. More than \$425 was collected and will be donated to Breast Cancer Options on behalf of the firm's staff.

Firm teams also participated in various Making Strides Against Breast Cancer events in New York. The F&P team raised more than \$600. LAW TO IMPROVE **BREAST CANCER DETECTION SIGNED**

In July of this year Governor Andrew M. Cuomo signed a piece of New York State legislation designed to help improve breast cancer detection and prevention by requiring mammography services to inform patients if dense breast tissue is found during an exam.

Dense breast tissue, although not abnormal, can make it harder to find cancer on a mammogram and may be associated with an increased risk of breast cancer. Flagging its detection during a mammogram will raise awareness about these associations. Women can use this information to talk to their doctors about their risks for breast cancer; at that time, it may be useful to seek for more follow-up screening tests and other preventive measures.

This new law will take effect in January 2013.

RECENT CASE RESULTS

\$725.000 PEDESTRIAN KNOCKDOWN

Our client was a town of Chester police officer who was struck by a vehicle while writing a ticket. He sustained injuries to his hips and back. The defendant's policy of \$25,000 was tendered. Our client was unable to return to work as a police officer and unfortunately had to retire. We were able to assist him in receiving medical and Social Security Disability Benefits.

\$899.200 MOTOR VEHICLE COLLISION

On November 1, 2012 after a damages trial that lasted nearly three weeks, a jury returned a verdict of \$899,200 in favor of our client. The victim, from Highland, NY, suffered a fractured foot, fractured wrist and a mild traumatic brain injury in an automobile collision in 2010. In addition, she was diagnosed with uterine cancer after the incident. The defense tried to raise a "seatbelt defense", where they claimed our client would not have suffered her head injuries if not for the fact that she was not wearing her seat belt. However, the jury discounted this defense and awarded our client and her husband

settled for.

\$200.000 WRONGFUL DEATH

Our client was a resident of the VA Medical Center at Canandaigua, NY. He was undergoing resident treatment for Post Traumatic Stress Disorder (PTSD) and related conditions as a result of his service in Afghanistan during Operation Enduring Freedom. Our client was admitted to the VA Medical Center on July 23, 2009 with a diagnosis of PTSD, history of Hepatitis C with abnormal liver functions, polysubstance dependence and major depressive disorder.

On August 14, 2009, our client signed out on a day pass from the medical center at 3:20 p.m. Surveillance tapes from the facility confirm that our client returned to the facility around 10:00 p.m. that night. There was no documentation showing that he was checked back into the

facility, nor was there any evidence that he was tested by a breathalyzer as required by the VA's own policy. Our client was found dead in his room at approximately 9:00 p.m. on August 15, 2009, a full day later.

No one bothered to check on the veteran despite his absence from meals and scheduled meetings during that time. The cause of death was determined to be "terminal aspiration with postural asphyxia." The VA's own records and statements indicate that he was not screened upon return to the medical center as required by the VA's policies and that the facility was unable to account for our client's whereabouts for almost an entire day while he was dead or dying in his room at the VA medical center from a condition easily treated with proper care. After honorably serving his country, this veteran was dead at the age of 24. This case was instrumental in making changes to the safety procedures at this VA facility.
