GOVERNOR ANDREW CUOMO ISSUES NEW LAW WITH TOUGHER PENALTIES FOR YOUNG DRIVERS WHO TEXT AND DRIVE

The Governor recently signed a new law that issues tougher penalties for drivers with probationary or junior licenses, who have been found guilty of texting while driving. He has also increased the number of points issued to all licensed drivers who are guilty of texting or talking on the phone while driving. The points increased from 3 to 5.

He also signed a law in 2011 that categorized distracted driving as a primary traffic offense. Law enforcement was then allowed to issue tickets for texting-while-driving. Within a year, there was a 234% increase in the number of tickets issued for texting and driving in New York State alone.

Governor Cuomo has dedicated a lot of time and effort to increasing our safety by reducing the amount of distracted driving on our roads. New York State Police are required to crack down on distracted driving, and now use undercover

NEW YORK'S NURSING HOMES EARN FAILING GRADE

According to Families for Better Care, a Florida-based nursing home resident advocacy group, nursing homes in New York State earn a failing grade when it comes to the care provided to residents.

The group published a first-ever state-by-state report card for nursing homes nationwide, using eight federal measures to analyze nursing home quality. The quality of care was so low in New York that it was the only state on the eastern seaboard to receive a failing grade.

When applying the measures to New York nursing homes, the group assigned a failing grade on half the measures, and assigned only one above average grade. The poorest grades were given to areas related to direct care staff hours, professional nursing services and ombudsmen complaints.

It was found that professionalism in nursing homes throughout the state was scarce, and residents received as little as 40 minutes of professional care per day. This was attributed to a lack of staff.

According to the report card, over 92% of the facilities were cited for one or more deficiencies, while ombudsmen verified 9 in 10 registered complaints.

\$765,000 TRIP AND FALL

Our client was leaving a friend's apartment in Newburgh on her way to a church function when she tripped and fell on an eroded concrete step. While falling she hit her head on the metal hand railing, damaging her spine in several locations. The Plaintiff was put on pain medication and given trigger point injections that offered no relief, and she eventually underwent spinal surgery. After two and a half years of treatment, our client was unable to walk without a cane and was awarded Social Security Disability. She endures constant pain in her neck and back and suffers from repeated severe headaches. An inspection of the step by our expert revealed that repairs to a similar erosion had been made in a nearby location, indicating that the defendant knew or should have known about this defect and repaired it. This case settled before trial.

\$150,000 AWARD REVERSAL OF VA DENIAL VETERANS SERVICES GROUP

As a result of his military service, our client was suffering from bladder cancer, as well as other serious disabilities. The Veterans' Administration had denied him a finding of Total Disability Due to Individual Unemployability (TDIU) and had awarded him only 20% disability for his service related bladder cancer. Our Veteran's Service Group submitted a Notice of Disagreement on the veteran's behalf. In 2013 the VA reversed it's decision on TDIU retroactive to 6/25/2003, and increased the disability for bladder cancer from 20% to 40%, retroactive to 10/20/10. This resulted in a cash award to our client of just over \$150,000 as well as an increase in his future disability payments.

\$152,000 REVERSAL OF VA DENIAL VETERANS SERVICES GROUP

Our client was denied service connection for Diabetes Mellitus, Type II with secondary connection for renal failure. Our Veterans Services Group submitted a Notice of Disagreement and a Statement in Support of Claim arguing that the Veteran served at the Udom Air Base in Thailand when herbicides were used. Our client was a military policeman who patrolled the boundaries and gates of the base. We requested that the VA concede to the Veteran's exposure due to the policy change of May 2010. Our client was awarded 100% service connection for Diabetes Mellitus Type II and secondary connection for renal failure retroactive from June 2008 to December 2012, then 80% from December 2012 until present.
