## REPLACEMENT FOR JETER-JACKSON

A replacement for former Legislator Barbara Jeter-Jackson, who died recently at age 82, will be appointed on June 15 by the City of Poughkeepsie Common Council.

Jeter-Jackson, a Democrat, was a longtime legislator representing District 10.

The county charter requires a vacant seat to be filled within 30 days by the municipality's board. The council's appointment will continue through the end of 2020. There will be an election for the seat on November 3, for the year 2021, and then again in November 2021 for the regular two year term starting January 2022.

Candidates had to submit an application to Councilmember At-Large Sarah Salem last week. Mario Johnson and Joash Ward were the only applicants.

Residents of District 10 were eligible to apply and will serve a population of 11,647, according

to the common council's public notice to fill the legislative seat.

"The City of Poughkeepsie Dutchess County suffered an immeasurable loss with the passing of Dutchess County Legislator Barbara Jeter-Jackson," Salem said in the public notice. "Through her work on the Poughkeepsie School Board, the Poughkeepsie Common Council, the Dutchess County Legislature, and throughout the community, Barbara Jeter-Jackson offered decades of selfless, exemplary, and upstanding service toward the betterment of our entire community."

The announcement of who will fill the vacancy will be made at the common council's meeting on June 15 at 6:30 p.m. Residents can tune into the webcast by visiting www.cityofpoughkeepsie. com/common-council. A majority vote by the whole council will decide who fills the seat.
